#### Schedule A

*In order to qualify as a Zambian Record the claimant must be a Zambia Sports Fishing Association member at the time of catching the qualifying fish. In addition, the fish must be caught on rod and line, be caught during a sanctioned ZSFA fishing event or competition and its weight measured on a certified and calibrated ZSFA scale within 24 hours of the same day as the fish is caught. In the case of a Line Class claim the weight of the fish must exceed the Line Class to qualify.*
